- 3. Public Participation (15 mins):

<u>Leak in Church Lane</u>: There is a water leak outside the Old Vicarage. The water authority has visited and cannot find a leak and it could be an old pipe. If they cannot find the issue they will pass it over to the Council.

**Bench at Recreation Ground**: The residents thanked the PC for installing the new bench at the back of the recreation ground.

<u>Small Business Grant</u>: The Church Institute, Scout Hut and Balsham Bowls Club have each received a  $\pm$  10,000 grant from SCDC. SCDC are still deciding if Balsham Pavilion can receive the grant.

Princes Close: When is it going to be resurfaced? Clerk to ask CCC Highways.

4. Minutes of the Parish Council Meeting held on 20<sup>th</sup> April, 2020: The previously circulated minutes were approved and signed.

# 5. Report from District and County Councillor:

**Geoff Harvey** (**District Councillor**): Green bin collections were delayed due to social distancing rules with 3 members of staff. The collections have resumed and will be at least once a month.

Grants have been encouraging everyone eligible to apply for the £ 10,000 grant.

COVID-19 shielding list are being sent out from SCDC.

Recycling centres opened on Monday and have been really busy.

The deadline for LHI bid submission has been extended.

Cambridge Community Capital Fund: PC to look at for community projects. £5 million in the fund.

Upgrades to A14 have finally been completed.

Traffic lights on A1307 need to be assessed. Clerk to email CCC.

Resurfacing of Princes Close to be chased up.

# 6. Matters arising from the minutes

a) Ditch at rear of Balsham Buildings: The ditch has been cleared out. The pipe needs to also needs to be cleared out and an official document for future maintenance for the ditch.
b) Street light contract: The street light contract has been converted to Haven Power.
c) Pond at Hunters Moon: James Kiddy contacted the wildlife society and they cannot do anything about the pond being filled in. Cllr Harvey offered to contact SCDC Planning.
d) Update on information from Diocese regarding Church Institute lease: Annie West to

speak to Gordon Fiddy and agree the wording of a letter to be sent to the Diocese.

**a**) **Foodbank report**: The Parish Councillors thanked Debbie Paton and Tracy Coston for running the foodbank. The foodbank is supporting 10 families with varying degrees of need and it is planned to continue to run until the end of June. Donations of food are slowing down.

The foodbank will be moved to the Pavilion as the Church Institute is going to be redecorated.

**b)** Covid-19 grants: A grant of  $\pounds$  2,000 has been received from Cambridgeshire Community Federation for the foodbank.

Highways to be contacted again as there is still a problem and PC would like to know what can be done about it. The water is bubbling up through the tarmac. Henry Batchelor will speak to Highways to ask about the flow of water and what investigations have been carried out. Helen Ford to put a post on facebook to gather evidence about accidents and issues that have occurred.
