# BALSHAM PARISH COUNCIL <u>Minutes of the Parish Council meeting held on</u> <u>Monday 15<sup>th</sup> January, 2024 at 7.30pm</u> <u>in Balsham Pavilion (Green Room)</u>

- 1. Apologies for absence: Kim Pearson and Cllr Geoff Harvey
- 2. Parish Councillor co-option: Jeremy Wade and Lynda Henderson applied to the PC for co-option. The PC had received a paragraph about each candidate before the meeting. The PC voted and Jeremy Wade was duly co-opted onto the Parish Council. Lynda Henderson was thanked for applying for co-option.
- **3.** Councillors are required to review the agenda, and to declare any pecuniary interest in any item.

James Kiddy registered an interest in 9a).

# 4. Public Participation (15 mins):

a) Balsham Feast funding: Debbie Paton and Glynis Hanlon attended the PC meeting to ask for funding for Balsham Feast. To reduce the costs there won't be any evening entertainment. There will be a mobile bar, café and food trucks at the Feast and the costs will be between  $\pounds$  3,000/4000.

The Balsham Feast Committee have asked the PC for a donation of  $\pounds$  800.00 towards costs.

**b) Cricket:** The Cricket Club have reported to the PC that there was an incident at the end of the cricket season a ball rebounded off the gym equipment, but luckily didn't hit anyone. The PC asked the Cricket Club to come back to the PC with some funded options for a mobile net to be discussed at the next meeting.

5. Minutes of the Parish Council Meeting held on 20<sup>th</sup> November, 2023: The previously circulated minutes were approved and signed by the Chair.

## 6. Report from District and County Councillor:

**County Councillor:** Civil parking enforcement: CCC have been trying to take the traffic enforcement off the police but there are only 2 traffic wardens across the whole District. The PC asked for the area around the school to be regularly checked.

The 20 mph application process is now open. The proposed Solar farmis between Balsham and West Wratting. Initial plans will be

released to the public next month.

Anaerobic Digester plant: The application is still live. Some of the statutory bodies have objected but no decision has been made.

# 7. Matters arising from the minutes:

a) Ownership, Illumination and other improvements to the Prince Memorial: The PC agreed to obtain new quotes for the additional paving outside the Prince Memorial and the replacing of the internal flagstones. Clerk to obtain Highways permission for the works and ask if planning permission is required.

c) Bus shelter refurbishment: The Clerk has chased the contractor for a date for the work to be completed.

d) Gigaclear information: No information has been received.
